Decline in fertilizer Subsidy

Will the Minister of **CHEMICALS AND FERTILIZERS** be pleased to state:

- (a) whether fertilizer subsidies have declined over the last few years;
- (b) if so, the details thereof;
- (c) whether the budgetary cut along with the decline in subsidies at a time when prices of fertilizers has risen sharply after the Ukraine war leading to its shortages has affected the farmers across the country;
- (d) if so, the details thereof and the reasons therefore, year-wise since 2010; and
- (e) whether the Government has taken any steps to incentivize farmers to continue agricultural operations in such situation and help them at field level?

(a) to (d): The expenditure incurred in the fertilizers subsidy in the 3 years is as follow:-

As may be seen there is no budgetary cut or decline in fertilizer subsidies and the availability of Chemical fertilizers in India has remained comfortable during the last 2 years i.e. 2021-22, 2022-23 and in the ongoing Kharif 2023 season.

(e): Under Urea subsidy scheme Urea is provided to the farmers at a statutory notified maximum retail price (MRP). The MRP of 45 KG bag of Urea is Rs. 242 per bag (exclusive of charges towards neem coating and taxes as applicable). The difference between the delivered cost of urea at farm gate and net market realization by the urea unit is given as subsidy to the urea manufacturer/importer by the Government of India. Accordingly, all farmers are being supplied urea at a statutorily fixed and subsidized rates irrespective of the cost of production/import of the urea.

As far as P&K fertilizers are concerned, Government has implemented Nutrient Based Subsidy Policy w.e.f. 1.4.2010 for Phosphatic and Potassic (P&K) Fertilizers. Under the policy, a fixed amount of subsidy, decided on annual/semi-annual basis, is provided on subsidised P&K fertilizers depending on their nutrient content. Under this policy, MRP is fixed by fertilizer companies as per market dynamics at reasonable level which is monitored by the Government. The current average MRP of P&K fertilizers gade-wise is enclosed as **Annexure – A.**
