#### **KRISHI UDAN SCHEME**

#### 818. SHRI R. DHARMAR

Will the Minister of CIVIL AVIATION be pleased to state:-

- (a) the salient features of Krishi UDAN Scheme;
- (b) the current status of this scheme in facilitating the international and domestic carriage of agricultural products;
- (c) the details of the airports covered under the Scheme across the country including Tamil Nadu along with the flights being run in different directions/locations thereunder;
- (d) whether Government proposes to expand the programme's scope beyond focusing on transporting perishable food produce; and
- (e) if so, the details thereof?

#### **ANSWER**

# Minister of State in the Ministry of CIVIL AVIATION (GEN. (DR) V. K. SINGH (RETD))

(a) & (b) Krishi Udan Scheme seeks to ensure seamless, cost effective, time bound air transportation and associated logistics for all agri produce originating especially from North East, hilly and tribal regions of the country. The scheme primarily covers 25 airports focusing on North Eastern, Hilly and Tribal region besides 33 airports in other regions/areas.

Krishi Udan is а convergence scheme where eight **Ministries/Departments** namely Ministry of Civil Department of Agriculture & Farmers' Welfare, Department of Animal Husbandry and Dairying, Department of Fisheries, Ministry of Food Processing Industries, Department of Commerce, Ministry of Tribal Affairs, Ministry of Development of North-Eastern Region are mandated to leverage their existing schemes to strengthen the logistics for transportation of Agri-produce.

In order to facilitate and incentivise movement of agri-produce by air transportation, the scheme envisages waiver of Landing charges, Parking charges, etc. provided for Indian freighters by Airports Authority of India (AAI) and Ministry of Defence at selected airports under the scheme.

- (c) The State-wise list of 58 Airports covered under the Krishi Udan Scheme is at Annexure. Coimbatore and Tiruchirappalli airports in Tamil Nadu are included under the Krishi Udan Scheme.
- (d) & (e) All agri and perishable commodities are already covered under Krishi Udan Scheme in the country which includes horticulture, fishery, livestock and processed products. Krishi Udan is an ongoing Scheme and is reviewed from time to time in consultation with stakeholders.
